- COVID-19
  - o Update
    - Not much change since last meeting still following COVID protocols as an agency/organization
    - Federal mask mandate extended until March 2022
- SMART Functional Updates
  - Training
    - Been working through some new hires and their training (three staff)
    - Big changes coming in February ELDT requirements (per federal mandate/Federal Motor Carrier)
      - Working with MNDOT/RTAP on training program
      - Trying to get new staff permitted before Feb. deadline
        - Specific training will be required before individual gets permit/license
    - Keeping busy with staff with other trainings (CPR, ongoing training, etc.)
  - Owatonna/Waseca
    - Waseca
      - Going well in Waseca Fully staffed
    - Owatonna
      - Short staffed
        - New driver starting today
        - Running advertisements everywhere
    - Season of Giving For the first time Owatonna/Waseca participated in the Santa for a Senior
      - Gifts will be delivered this week
  - Austin/Albert Lea/Dispatch
    - Austin
      - Two full time driving positions open
        - Have made offers but haven't had the luck we would like
      - Have reduced some service due to staffing shortages (Purple/Shuttle)
    - Albert Lea
      - Fully staffed and going well
      - All services are operational (route and demand response)
- Staffing
  - o Continues to be our number one challenge in multiple communities
  - Reduced service in Owatonna and Austin due to staffing issues
- MNDOT Grant Update
  - Operating (2022)
    - Approved by MNDOT
    - Full support from MNDOT through 2022 (100%)
  - Operating (2023 and beyond)
    - With federal infrastructure bill more funding coming to transit in future years MNDOT is working through numbers but good reason for optimism
  - Capital
    - Vehicles
      - Vehicle Replacement
        - Ordered six replacement buses (from 2020 capital grant; two in Austin, two in Albert Lea, one in Owatonna, and one in Waseca)
        - Ordered five replacement buses (from 2021 capital grant; one in Austin, one in Owatonna, and three in Waseca)
        - Completed application for 2022 vehicle replacement
          - Requested five vehicles
          - Submitted application in October
    - Facilities
      - Owatonna facility

- Ground/foundation work has started Completed for the winter
- Remaining timeline
  - April Building construction
  - August (into the fall) Move in
- Austin and Waseca facility approved through MNDOT grant Future projects
  - o Austin scheduled for 2025; Waseca scheduled for 2026
- Other
  - Vehicle Maintenance Software
    - Requested vehicle maintenance software as part of the 2019 grant and was approved
    - Will be purchased and installed sometime in 2022
- Big Picture Down the Road
  - Shared Mobility Opportunity
    - Ecosystem in communities where the public would have access to a platform that would help guide them to various mobility services (in some cases it could be multiple services to complete their trip)
    - Waiting for MNDOT to secure vendor contract will continue to update group as developments take place
  - Staff Meetings
    - Continue to work through annual staff trainings
      - All-staff training held last month Well attended and successful
  - Cedar Valley Services Update
    - Still working on bringing consumers back to the program
      - Still have some that have not returned
    - Working through staffing problems
      - Will bring more consumers back once staffing levels out
    - Continue to follow COVID protocols as a state-licensed agency
      - Various mandates that are required
        - o Monitoring what will be needed and ready if changes are needed
        - Vaccinate or test requirement may be needed

- Continue to keep staff and passengers safe
- Continue to streamline and simplify processes and policies
- Work to grow ridership out of COVID Pandemic
  - o Gain rider trust
