- Owatonna Lead Driver Julio Zavala Lopez traveled to Oklahoma City in May to compete at the 32nd Annual National Community Transportation Roadeo (traveled with Operations Managers Joanne Brackey – Training and Compliance, and Todd Brackey – Fleet and Facilities)
- Punched his ticket to National Roadeo as a winner of the Minnesota 2022 Roadeo in Austin (1st
 Place in Small Bus competition and Driver of the Year Award)
- 67 total drivers from all over the United States
- Julio won the Most Spirited Driver Award voted by his peers as the most friendly and helpful

- Training
 - CTAA
 - Was a great experience a total of six days
 - Attempted to be a judge but was unable to due to too many others already signed up
 - Was able to learn a lot about the Roadeo that we can utilize at our local state Roadeo
 - Some really good training opportunities throughout the week

- Had a great Expo that had some really cool and new stuff regarding transit (vehicles, technology, etc.

 - Held a new hire training yesterday with SMART staff (also had staff from another agency as Joanne is a state RTAP training)
 - Will be holding a CPR training in July (evening class to help with scheduling)
 - Have a new hire starting in early July

 - Really struggling with staffing in northern counties both cities are feeling a pinch
 - Continues to be the biggest challenge

- Austin/Albert Lea/Dispatch
 - Austin
 - Have an interview tomorrow
 - Assisting some area programs with trips on Demand Response services
 - Albert Lea
 - Recently lost two really seasoned drivers (FT & PT)
 - Replaced them already (one transfer from Austin)
 - Assisting some area programs with trips on Demand Response services
 - Dispatch
 - FT dispatcher retired in March and has been replaced
- MNDOT Update
 - Capital
 - Vehicles
 - Vehicle Replacement
 - o 2020-21 Bus Grants/Contracts
 - Ordered six replacement buses (from 2020 capital grant; two in Austin, two in Albert Lea, one in Owatonna, and one in Waseca)
 - Received first bus from 2020 order in May, 2022
 - Ordered five replacement buses (from 2021 capital grant; one in Austin, one in Owatonna, and three in Waseca)
 - 2020-21 Bus Contracts received amendments due to pricing increases
 - Expecting select buses to be delivered as soon as late spring/early summer
 - Scheduled to receive four buses this summer (mid-July hopefully)
 - Two buses scheduled to arrive mid-fall, with last four buses coming Q1 2024
 - o 2022 Bus Grant/Contract
 - Approved for two buses from 2022 Vehicle Replacement grant; one in Austin, one in Albert Lea
 - Two buses have been ordered through North Central
 - o 2023 Vehicle Replacement
 - Requested eight buses for replacement, was approved for four (award letter)
 - Two buses in Austin, two buses in Owatonna
 - Significant price increase:

- Nearly 40% over 2022 ordering price
- Increase of 101% from 2021 ordering price
- Recently received notice of yet another increase Now approx.
 115% increase over original 2020 price
- Likely order buses later this fall
- Low-No Emission Grant BETTER
 - Worked with MNDOT and three other agencies to apply for an exciting opportunity to bring an electric bus to SMART
 - "Buses Electrified To Travel Efficiently in Rural" MN Communities application was completed the last week of May
 - o Notice was received mid-August, 2022, that MNDOT's grant was approved
 - Tentative time for bus arrival is 2025
- Facilities
 - Owatonna facility
 - Open House went very well great turnout from MNDOT, Cedar Valley, and some passengers
 - Austin and Waseca facility approved through MNDOT grant Future projects
 - Austin scheduled for 2025; Waseca scheduled for 2026
- Other
 - Have started initial planning for 2024 will start piecing together the 2024 Operating grant application soon – Has been delayed due to historic Transportation package that was passed this last legislative session (extra dollars for transit)
 - Grant application was posted on MNDOT site today (6/21/23)
 - 3% increase for 2024
 - 5% local share for 2024
 - Due 7/31/23
 - Awarding set for October
- Big Picture Down the Road
 - Resume normal service hours
 - Looking at services and resume as able (staffing)
 - Cedar Valley Services Update
 - Parent company for SMART Has been doing transit for nearly 20 years now
 - Transportation is important aspect of helping disabled individuals in the community
 - Continue to deal with staffing challenges
 - Struggled with transportation while local taxi company in Albert Lea was not operational new one is up and running now

2023 Program Goals (carried over from 2022)

- Continue to keep staff and passengers safe
- Continue to streamline and simplify processes and policies
- Work to grow ridership out of COVID Pandemic
 - o Gain rider trust
- Any new goals/ideas?
