What's New

- Comprehensive Review
 - SMART will be undergoing a Comprehensive Review by OTAT/MNDOT this summer
 - This is a statewide event with all agencies being reviewed
 - OTAT is hoping to complete these every three years
 - Consists of OTAT staff and consultants will review policies, procedures, etc.
- Community Engagement
 - CVS/SMART is partnering with local United Way organizations this summer to help collect items for their 'Success Closet' – an endeavor that provides people in need with essentials, from socks to lice kits, and shampoo to blankets.
 - This is part of the 'Connect Committee' that CVS/SMART has to help employees engage with the community efforts the same group that coordinates the popular 'Santa for a Senior' event.
- MPTA Bus Roadeo
 - Taking place next month in Virginia MN
 - SMART sending at least one driver and two judges

SMART Functional Updates

- Training / D&A
 - Will be preparing for a MNDOT audit on the Drug and Alcohol side of things later this fall
 - Been working on some new hires as of late
 - Working with existing staff on refreshers
 - Focusing on summer staff meetings / trainings
- Albert Lea
 - Fully staffed!
 - Daycares have been calling in and setting up trips to various locations
 - Will have the annual Freeborn County Fair service this summer
 - Working on staff meetings with Joanne
- Austin/Dispatch
 - Staffing is full for the first time in six years!
 - Austin does a lot of preschool during the school year so a little slower as well
 - Have partnered with Mayo to provide free trips to seniors in Albert Lea for medical appointments (on top of Austin which has been place for over a decade) – has been a great start with over 100 a month at times
- Owatonna/Waseca
 - Waseca Still low on staffing; have hired a few but they haven't worked out like we had hoped for
 - Some parents have scheduled trips for their children to summer school
 - Owatonna Staffing has been more positive as of late
 - Have hired two part time drivers in the last week, and a full timer that started and is now fully licensed
 - Just expanded our South Run by an hour due to additional staff
 - Gearing up for PreK this fall

MNDOT Update

- Operating
 - Operating application now open through MNDOT due June 30th
 - Update budget numbers as well as service levels (hours)
 - Will receive notice later this fall
- o Capital
 - Vehicles
 - Vehicle Replacement
 - o 2023 Vehicle Replacement

- Requested eight buses for replacement, was approved for four (award letter)
 - Two buses in Austin, two buses in Owatonna
- Ordered four buses in early November, 2023 two with I State and two with North Central
 - Two buses received from I State in mid-January; two from North Central delivered May 21
- 2024 Vehicle Replacement
 - Requested eight replacement vehicles, was approved for three
 - One Albert Lea, two Austin
 - Ordered three buses in late January; hopefully receive them by year end
- 2025 Vehicle Replacement
 - Grant application submitted requested six buses
 - Approved for one bus in Owatonna
- 2026 Vehicle Replacement
 - Application process is open now closes at the end of June
 - Will request seven replacement vehicles
 - Notification from state expected in early 2026
- Vehicle Disposition
 - Disposing of older buses as new ones arrive
- Low-No Emission Grant BETTER
 - Some challenges with the EV options available has led to two agencies dropping from the BETTER project – SMART and Prairie Lakes (Fairmont/Blue Earth) remain and are working with the state on options
 - Possibilities of additional buses may be an option due to agencies that dropped out; will know more in the coming weeks
- Facilities
 - Austin and Waseca facility approved through FTA grant (partnership with MNDOT)
 - Currently working through the NEPA process (federal requirement for projects)
 - Will be doing both projects with similar timelines
- Other
 - Submitted 2025 Technology Grant application for new routing software
 - Awaiting announcement of awards
 - Submitted Capital grant for staff support vehicle possible approval in the near future
- Big Picture Down the Road
 - o Resume normal service hours
 - As SMART continues to hire more staff, we will evaluate our services and resume previously suspended services as we are able
 - Cedar Valley Services Update
 - Provides work service for people with disabilities in Austin, Albert Lea, Owatonna, and Faribault
 - Will be having summer picnics this summer
 - Continue to look at hiring more staff

2025 Program Goals – Ideas?

- Continue to streamline and simplify process and policies
- Fill open staffing positions throughout agency and resume suspended services
